2. The last date for submission of the quotation is 23.9.2008 by 3.00  
P.M. The quotation shall be opened on the same day at 4.00 P.M.

3. You are also requested to furnish the names of at least 2  
organizations of repute (preferably Government organization) where similar  
wood paneling work has been carried out by you during the last 3 years.

4. Your quotation will be evaluated by a Committee of officers in the Central Information Commission. Subject to the satisfaction of the Commission on your fitness for carrying out the work, the contract will be awarded to the lowest bidder. The decision of the Commission on the matter of fitness will be final.

6. The award of the contract will be subject to the following terms and conditions:-

- (i) The Central Information Commission reserves the right to reject any or all of the quotations without assigning any reasons therefor.
- (ii) The CIC reserves the right to terminate the contract without any clear notice and without assigning any reasons whatsoever.
- (iii) The charges on which the contract is awarded shall not be reviewed for enhancement at any time after award of the contract.
- (iv) In the event of any loss incurred by CIC on account of negligence of the contractor, the latter shall compensate the loss either by replacement or by payment of adequate compensation, failing which the amount of loss will be deducted from the amount payable to the contractor for the work. Decisions of the Commission on the nature of loss and the amount to be payable as compensation will be final.
- (v) The contractor shall be responsible for the conduct and behaviour of the persons and /or any of his employees / labourer assigned for the said work while executing the work.
