Agenda - 2 Note on provisionally registered cases in the database – for decision

The Commission took note of the provisionally registered online cases, pending disposal. The Commission further noted that around 9500 provisionally registered cases are lying pending for want of further necessary documents in the data base and that these provisionally registered cases also constitute part of the pendency over and above 17786 as on 29th February, 2012.

The Commission decided that it cannot wait ad infinitum for the necessary documents and directed the Secretary to update the data base by treating these provisionally registered cases as infructuous entries. However, it directed that they will not affect the number of disposals in the Commission. It desired that from April 2012 the reporting of the pendency of cases would discard these provisionally registered cases and in future the provisionally registered cases would not be reported as registered case.

Agenda - 3 A note on Central Registry of the Commission

The Commission discussed the proposal for inception of the central registry. It directed the Secretary to re-examine the proposal in view of discussion and note of

IC(DS) and present the same in its next meeting. If the Secretary is of the opinion that the proposal is not workable, the Commission may be accordingly informed.
