CIC chaired the meeting and all Information Commissioners were present. Following decisions were taken or suggestions made in the meeting:-

- 1. It was decided to reallocate work among Commissioners as per Annexure.
- 2. It was decided to appoint Consultants to devise internal procedure i.e. how to deal with complaints/appeals, setting up monitoring system, etc. It was suggested that we may find out from National Judicial Academy, Bhopal whether they can take up the work.
- 3. DOPT may be asked to frame rules and procedures to comply with the provisions of the RTI Act by Bodies/NGOs substantially financed by Government.
- 4. It was felt that at some later date, a meeting with State Information Commissions may be organized to consider matters which may have common jurisdiction and other procedural matters.
