# Minutes of the meeting held on 31st March, 2020 at 1100 hrs.

### The following points were discussed:-

## 1. Issue of notices and listing of cases for disposal of RTI second appeals:

The Deputy Registrars will fix dates in consultation with the ICs and issue the notices in all cases where the contact details of the parties are available. The contact details of nodal CPIOs will be made available, public authority wise to the Deputy Registrars.

The Registrar will continue to train all the DRs periodically to iron out any administrative / technical support issues with NIC and ensure that the scheduled hearings commence through audio / digital mode by 15<sup>th</sup> April, 2020, if not earlier in larger public interest.

## 2. Arrangements for cleaning and sanitation in the CIC building:

The CIC building will be sanitised by the NSL regularly using a reliable and effective system. The designated officer in charge will ensure proper hygiene and sanitation of the CIC premises and certify the same.

# 3. Arrangement for passes for the staff of the CIC to make movement whenever necessary:

Request will be made to the Delhi Police to issue passes to the essential staff of the ICs and others.

# 4. Operation of e - office:

E-office platform will be extended by NIC to the home computers of the CIC officers in the hierarchy of the channel of submission of files.

### 5. Settlement of pending claims:

For the lockdown period, requirement of submission of latest medical prescriptions for purchase of routine drugs like blood pressure, diabetes, etc. will be relaxed. The medical and other bills may be submitted on e-mail.

- The Commission reiterated that no reference whatsoever be made to any external (ii) authority for opinion / advice without the approval of the competent authority in the Commission.
