ORDER

With reference to GFR 163 & 164, the Central Information Commission hereby extends the period of consultancy of Dr. M.K. - iii) He shall not be entitled to any perquisites such as HRA, CCA, TA, residential accommodation, transport facilities and any kind of regular leave except o8 days Casual leave plus 02 days restricted leave in the calendar year. The leave shall not be carry forwarded.
- iv) No TA/DA is admissible to him for joining the assignment or on its completion. If he is required to travel outside Delhi in connection with the work of the Commission during the period of his engagement, he will be entitled to draw TA/DA as per normal rules as applicable to any serving officer on an equivalent rank in the Commission.
